Tuition can be paid in two ways: in full prior to August 1, or through monthly financing at First Bank & Trust (website: [tuitionportal.fbtonline.com](http://tuitionportal.fbtonline.com)). The deadline for setting up bank financing is June 1. For your convenience, the Academy offers tuition financing, which can be paid in 10 monthly installments to First Bank & Trust. If you register after the financing deadline, payment for the months(s) missed will be paid to the BMA registrar's office along with the registration fee, and the remaining tuition may be financed. All families of Bishop McManus Academy can be approved for financing; however, **if the account is reported as delinquent, the student will not be allowed in class until the account is paid. There will be NO EXCEPTIONS to this policy. In the event of a delinquent student account, the student's seat could be made available to new, incoming students, thereby jeopardizing your child's place on the student roster.**

Tuition is charged on a yearly basis. Once your child is enrolled at Bishop McManus Academy, you become responsible for the entire year's tuition and fees. Tuition, registration fees and all other fees are non-refundable for any reason. **If your child is withdrawn or expelled, you will be held liable for the entire year's tuition, curriculum fees, uniform fees and any other fees that have been charged to your account.**
